### LAP/HPA Update

- Update was presented by Tess. Mark Wedge, chair of the HPA Tagish River planning committee since 2016, also fielded questions. Tess presented the committee's workplan for 2019 the hope is to have a draft plan by month's end which would then to go to the federal government, Yukon Government and CTFN), and then to the public in May 2019.

The committee is looking for help in generating public interest in the plan and intends to be present at Ida's swans talks and fishing events.
