Hi Tagish LAC:

I haven't heard from CTFN on their water delivery list, so how about we proceed with Plan B and send out an email questionnaire to the Tagish community list?

I called Yukon Water Services (which is partly owned by Teslin Tlingit First Nation Development Corporation). Just as an indication of what other people are paying, to get water delivered to Marsh Lake, it costs:

- \$ 140 for 750 gallon tank
- \$ 220 for 2 000 gallon tank.
- Yukon Water Services delivers every Friday to Marsh Lake.

As a start, and please edit as you desire:

*The Tagish Local Advisory Council has heard some concerns from the community about local water delivery. The present system of water delivery from the Carcross/Tagish First Nation might not continue into the future and the Tagish LAC and Community Services would like to be proactive about looking for other solutions.*

*We are canvassing the community to determine the water delivery needs of the residents of Tagish, both part-time and full-time.*

1. *Do you currently have water delivery?*
2. *If you do not currently have water delivery, would you be interested if it was available in the future?*
3. *What size is your water tank?*
4. *How often is water delivered to your home?*
5. *How much do you currently pay?*

We might want to ask people how much they would be willing to pay, with the context of how much it costs in Marsh Lake.

Please modify as you choose.
