1. Call to Order – 1:00 pm

- 2. **CHAIR**, Vicki Hancock, noted that a Quorum is present as required to proceed and thanked all who came.
- 3. **MOTION**: To adopt the Agenda. Shelley Penner/Lorraine McNabb. Carried.
- 4. <u>MOTION</u>: To adopt Minutes from AGM June 19, 2013. Susan Baker/Judy Harwood Dabbs. Carried.
- 5. <u>OLD BUSINESS</u>: Judy Dabbs asked about #12 in the 2013 AGM Minutes, the need to find storage for the chairs and tables to ensure safe exit from the building in case of an emergency brought forward by Maureen Dastous. President, Paul Dabbs, responded that the corridor has been cleaned and chair storage improved upon however not fully resolved at this point.
- 6. President/Recreation Director's Report for year, June 2013 June 2014. Peter Hamm, elected President at the 2013 AGM, resigned in March for health reasons. Staff Recreation Director, Colin Hickman, resigned his position at the end of April to take a position with the Aboriginal Sports Development Association in Whitehorse, YT. Cleo Hosni and Shylo Van Delft, Assistant Rec. Dir's, filled in some of the duties of the position since that time as long as they were able. Paul has been Acting Rec Director since Colin's departure. Paul's written report is therefore a combination as President and as Rec Director. In summary, despite a number of challenges, it has been a positive and improved year for the TCA.

From the floor both Paul Dabbs and Peter Hamm were thanked for their many hours of contribution to the operation of the Tagish Community Association.

7. <u>Treasurer's Report</u> – June 1, 2013 – May 31, 2014 – Delivered by Louise Girard and Shelly Penner. Copies of the Financial Statement for the fiscal year, 2013/14 were provided. Louise explained the contents and answered questions from the floor. High points were that the TCA completed a Review required by Yukon Government and Balance Statements now reflect a Depreciation on assets that previously was not

calculated. Thank you was expressed to TCA's former bookkeeper, Leah Verishine,for her assistance in helping with the review. Extra funding was received over the year for the purchase and installation of a new furnace, a new hot water tank and a new dishwasher. Many, many hours have been volunteered by Judy Dabbs, Louise Girard and Shelly Penner as the TCA transition from the use of a bookkeeper and Simply Accounting to the use and implementation of Excel. Those present thanked the 3 volunteers for the time they have spent.

MOTION: To accept the TCA Financial Statements for the fiscal year, 2013/2014 as submitted. Lorraine McNabb/Susan Baker. Carried.
